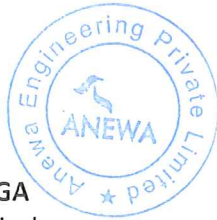

MEMORANDUM OF UNDERSTANDING**BETWEEN****ANEWA ENGINEERING PVT. LTD. & PDA COLLEGE OF ENGINEERING****(Branch: Electronics and Instrumentation Engg.)**

This Memorandum of Understanding (MoU) is entered between Anewa Engineering Pvt Ltd a company incorporated under the Indian Companies Act, 1956 having its registered office, located at Hyderabad, Telangana and a Karnataka based College represented by undersigned of the OTHER PART; whereas ANEWA and PDA College of Engineering shall be hereinafter jointly referred to as the "Parties" and singularly as a "Party".

The Parties has decided to agree to establish Industry-Academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MoU), ANEWA and College I University agree on following activities:

1. Anewa shall help the students of PDA college of Engineering studying in the course for BE / B Tech from 1Yr to 4Yr or SEM system course to undergo Industry Training or Internship for the fulfillment of Academic Degree. Once a curriculum is designed and courses relevant to industry are offered at College I University.
2. Manager/ Senior Engineers AN EWA will share their knowledge and experience by way of taking sessions, participating in Inter active sessions with Students periodically helping to bridge the Industry Academic gaps. In turn College shall arrange to send their Faculty Members/Students to Anewa office, Hyderabad at their cost periodically based or as decided upon mutually for understanding the Latest technology/Design concepts/etc. to make students readily employable.
3. ANEWA will offer Internship/ Projects to interested students of College I University at its ANEWA Head office, Hyderabad, India so that the students get hands on experience of Industrial Projects. Anewa shall arrange to provide the internship on either past or live project or any other project based on availability of Time and manpower/Guide. The number of students, who can be considered for Internship/Project, would be as mutually decided between ANEWA and College. The period of internship will be decided based on Project type.
4. College shall arrange for accommodation/boarding/local transportation for their Faculty / students. The session will not be more than 4-6Weeks or as required and for 3-4 hours per day.
5. Project/ Data confidentiality shall have to be maintained by Students while working in office and if found any irregularities or behavioral issues. Anewa shall have every right to terminate the Project with an intimation to college authorities with immediate effect.
6. Anewa shall NOT PAY any Stipend/ Renumeration/Salaries/Nor any amount to students for carrying out internship in our Company and will only help to fulfill their partial requirements of academic qualification for doing an internship on request of college authorities.
7. ANEWA shall not bear responsibility of Employment upon completion of internships or Projects for students of College or University. However, if any vacancies exist /or during recruitment the students will be considered on priority for placements solely based on interview and written test performance of students as per procedures laid down by Anewa.




8. ANEWA may participate in campus placements; when it does so, college students will be given priority status for placements etc.
